APPLICATION FOR VISA - GUIDANCE NOTES

Tourist Visas can normally be issued on the same day by prior arrangement with Mrs. Wishart - 0141 353 5090 or e-mail thaiconsulglasgow@btconnect.com . Please hand your application into reception at 4 Woodside Place, Glasgow G3 7QF in an envelope marked "Thai Consulate" before 10.30am and your visa can be picked up at reception after 2pm. Non Immigrant Visas have to be approved by the Embassy in London and therefore may take 2-3 days for approval.

Outwith the hours when the Consulate is open i.e. 9.00 am – 2.00 pm, you can hand your documents IN AN ENVELOPE marked "Thai Consulate" to the receptionist at 4 Woodside Place, accompanied by a SPECIAL DELIVERY STAMPED ADDRESSED ENVELOPE if you want the return of your passport by post. Reception is open from 9am until 5pm Monday to Friday. In an emergency, a personal application may be made outside the hours when the Consulate is open by prior appointment with Mrs. Wishart. The Receptionist DOES NOT WORK FOR THE THAI CONSUL and cannot answer any queries regarding visas but will accept your envelope and pass it on to the Consulate.

1. ANY PERSON APPLYING FOR A VISA SHOULD HAVE A CURRENT PASSPORT VALID FOR AT LEAST SIX MONTHS FROM DATE OF APPLICATION. VISAS CANNOT BE POST-DATED OR ISSUED ON A POST-DATED PASSPORT.
2. No visa is normally required for tourists to Thailand holding UK passports who arrive and depart by air, HOLDING CONFIRMED AIR TICKETS out of THAILAND within 30 days. After 3 visits in one year to Thailand under the 30 day rule, ALL visitors MUST apply for a tourist visa - valid for 60 days. Holders of non UK passports must check with the Consulate if a visa is required.
3. Visa fees are payable in CASH or POSTAL ORDER made payable to "Royal Thai Consulate". CHEQUES ARE NOT ACCEPTABLE.
4. The following types of visa are available from this Consulate:-
 - (A) TOURIST VISA - SINGLE ENTRY - FEE £30 - valid for 60 days from date of entry. The period of the validity for non UK passports holders can vary. Holders of such passports should check the period of validity with the Consulate. All single entry visas are valid for entry into Thailand within three months from date of issue.

TOURIST VISA – MULTIPLE ENTRY - FEE £150 - valid for 6 months from date of issue and each entry being valid for 60 days.

Supporting documents required:-
 - (a) Original bank statement showing a balance of at least £5000 or a print-out with official stamp of the bank.
 - (b) A letter from your employer confirming your employment addressed to the Royal Thai Consulate.
 - (c) If you are self-employed, your self assessment HMRC SA100 for the last year and a company registration document..
 - (d) Photocopy of confirmed air ticket.
 - (e) Photocopy of hotel reservation in Thailand.
 - (B) NON-IMMIGRANT VISA – SINGLE ENTRY £60.

This type of visa should be applied for by any person who is going to Thailand for business, visiting relation, retirement or any purpose other than tourism. In the case of a business visa, a letter from a company, organisation or institution guaranteeing the applicant's repatriation must be included with the application together with the company registration document. If visiting a spouse, a copy of the original marriage certificate and a copy of spouse's passport and ID, must be submitted to the Consulate. If going to Thailand for teaching purposes, a police criminal record clearance certificate or Disclosure Scotland together with an invitation letter and company registration document and copy of degree must be submitted. For retirement visas, all Consulates can only apply for approval for persons over 65 years of age. A letter from your pension provider is required confirming your pension. This single entry visa can be extended at immigration in Thailand. All persons under 65 years of age must apply to the Embassy in London for a retirement visa.

.Consulates are no longer able to issue multiple entry non immigrant visas. Multiple entries can only be applied for at the Embassy in London in person or by post.
 - (C) A Transit visa is available in very limited circumstances- £20 per entry.
5. There are no health requirements for entry to Thailand except in the case of persons coming from a yellow fever area.
